Speed Business Meeting

Principle

This type of meeting provides each participant a unique opportunity to present products or services of the company s/he represents within eight ten-minute one-to-one meetings. In addition, participants may also briefly discuss common business interests and the potential for future cooperation. Developing new business contacts continues throughout the banquet following the meetings. In this way, you extend your network of contacts by companies from various industries in a very short time. Thanks to the cooperation of three foreign chambers of commerce, you can meet company representatives, who you usually do not have the chance to meet at the events of your Chamber of commerce.

How does the event work?

- ↓ Upon registration, you will receive a ticket with a table number and a letter "A" or "B"
- ↓ Participants with letter "A" will sit on the outer side of the negotiating tables, guests with letter "B" will sit opposite
- ↓ When you hear the signal, each participant has three minutes to present their company, including its products and services to his/her counterpart. During the remaining four minutes, both parties can discuss possibilities of mutual cooperation
- ↓ After 10 minutes the signal sounds again and participants with letter "A" will move clockwise to the next table

Note: If your counterpart fails to appear for the first meeting, you will be placed at another table.
