SPEED BUSINESS MEETING

PRINCIPLE

This type of meeting provides each participant with a unique opportunity to present products or services of the company he/she represents and its business needs during 10 one-on-one meetings. In addition, participants may also briefly discuss common business interests and the potential for future cooperation.

HOW DOES THE EVENT WORK?

- Upon registration you will receive a ticket with a table number and a letter "A" or "B".
- The number identifies the table for your first meeting. Participants with letter "A" will sit on the inner side of the negotiating table, those with letter "B" on the outer side.
- After the signal each participant has 3 minutes to present his/her company and its products or services. During the remaining

- 4 minutes both parties can discuss the possibilities of mutual cooperation.
- After 10 minutes the signal sounds again. Participants with letter "A" will remain seated while those with letter "B" will move clockwise to the next table.

If your counterpart fails to appear for the first meeting you will be placed at another table.
